A **Mandatory** Pre-Bid Conference will be held **at 10:00 a.m. on April 5, 2018** in the City Council Chambers, City of Bunker Hill Village City Hall. A site tour will be conducted immediately following the pre-bid meeting.

Work under this Contract includes, but is not limited to, the following: The installation of reinforced concrete boxes, reinforced concrete pipe, HDPE pipe, sanitary sewer of various sizes, water lines, including all necessary appurtenances. The work also includes concrete and asphalt paving, concrete sidewalks, reconstruction of residential driveways, tree removal and protection, sodding, utility service reconnections, traffic control, and site restoration.

Bunker Hill will give notice of the contract award within sixty (60) calendar days after the opening date and time.
